Sessions will address Negotiation of Indian Water Rights Claims: The Basics, Post- Settlement Management Issues, The Administration's Settlement Policy, and Settlement Legislation: Getting Bills Through Congress. The symposium will begin Wednesday, September 14 at 8:30 a.m. and continue through the day, with an evening reception. On September 15, discussions will continue throughout the morning, followed by a social/cultural event that afternoon and evening. The Symposium will conclude September 16 at noon after a morning discussion panel. Each attendee will receive materials.
