1. That I am the duly appointed and acting Clerk of the Shoshone & Arapaho Tribal Court and in such capacity I am custodian of the records of the Shoshone & Arapaho Tribal Court and am familiar with the Court's authority, membership and activities.

That under §1-8-1 of the Shoshone & Arapaho Law & Order Code ["S&A LOC"], it is my duty to keep available for public inspection during regular business hours copies of the Shoshone & Arapaho Law and Order Code, and any amendments thereto, plus copies of all laws or rules which have been incorporated by reference from other jurisdictions, plus a copy of the Code of Professional Responsibility of the American Bar Association.


