1	SECTION 1	DECLARATION OF POLICY
2		It is the declared policy of the Tohono O'odham Council to provide
3		for the conservation and restoration of national lands and soil,
4		moisture and watershed resources, for the control and prevention of
5 6		floods, soil erosion and sedimentation, the preservation and im-
7		provement of soil fertility, and the beneficial use of flood waters,
8		and thereby to conserve, protect and enhance the lands, vegetation,
9		wildlife and the scenic, recreational and natural resources of the
10		Tohono O'odham Nation, and in such a manner to promote the public
11		health, safety and general welfare of the Tohono O'odham.

13	SECTION 2	SOIL AND WATER CONSERVATION DISTRICT ("SWCD")
14		For the purpose of administering this ordinance, there is hereby
15		established the Soil and Water Conservation District of the Tohono
16		O'odham Nation, hereinafter referred to as the "SWCD", a govern-
17		mental division of the Nation, under the authority and direction of
18		the Board of Directors of the SWCD.
19	SECTION 3	SWCD BOARD OF DIRECTORS: APPOINTMENT: VACANCY: ADVISORY MEMBERS
20 21		A. The SWCD Board of Directors shall consist of eleven members who
21		shall be appointed as prescribed in subsection B.
23		B. The Council of each of the eleven District of the Tohono O'odhar
24		Nation shall appoint a director and alternate to the SWCD Board.
25		Appointments made by the Districts shall be subject to confir-
26		mation by the Tohono O'odham Legisltive Council. Directors may
27		be removed from the SWCD Board at the discretion of the Council
28		of the District from which they were appointed. Candidates for
29		such offices must be members of the District of the Council ap-
30		pointing them. Each director shall have one vote on the SWCD
31		Board. In the absence of a director, the alternate may sit and
32		vote in the director's place.

2			except that the director or alternate appointed to the initial
3			SWCD Board by the Councils of the following Districts shall
4			serve for terms of two years, namely; Baboquivari, Chukut Kuk;
5			Gu Achi, Gu Vo, Hickiwan. Appointments to the SWCD Board shall
6			thereafter be made every two years, and the terms shall be
7 8			staggered so that no more than six directors and alternates
9			
10			shall be appointed in the same year.
11		D.	If a vacancy occurs in the office of a director otherwise than
12			by expiration of term, the alternate shall take the place of
13			the director, and the Council of the District which made the
14			original appointment shall appoint a successor alternate, to
15			serve for the remainder of the original term.
16		Ε.	The following persons shall be ex-efficio, non-voting advisory
17			members of the SWCD Board: (1) the District Conservationist of
18			the United States Department of Agriculture, Soil Conservation
19			Service, (2) the Land Operations Officer of the Sells Agency,
20			(3) the General Manager of the Farming Authority of the Tohono
21			O'odham Nation, (4) the Director of the Agricultural Extension
22 23			Service of the Nation, (5) The Director of the Environmental
23 24			Health Department of the Tohono O'odham Nation, and (6) the
25			Water Resources Director of the Nation. The SWCD Board may
26			appoint additional advisory members to the Board. Appointments
27			shall be subject to confirmation by the Chairman of the Tohono
28			O'odham Nation.

11	SECTION 5	POW	IER AND DUTIES OF THE SWCD BOARD

13		Α.	The SWCD Board shall have the power from time to time to make
14			such recommendations to the Natural Resources Committee of the
15			Legislative Council not in consistent with this ordinance as it
16			may deem necessary for the efficient administration of this

A. The SWCD is empowered, subject to the limitations contained in its operating budget approved by the Tohono O'odham Council, to:

1. Conduct surveys, investigations and research relating to the character of the soil, soil erosion, flood water, flood control, non-point water pollution, sediment control, watershed development, methods of cultivation, farm and range practices, seeding, eradication of noxious growth, and relating to wildlife, fisheries, outdoor recreation, and such other measures as will aid farm and range operations, disseminate information and carry on research programs in cooperation with national, federal and other agencies, not inconsistent with existing policies of the Tohono O'odham Nation.

 Conduct demonstration and training projects pertaining to all aspects of soil and water conservation, restoration and utilization.

3. Cooperate and enter into voluntary agreements with land users, farmers, ranchers, farm and livestock associations and cooperatives, and agencies or subdivisions of national, federal and other governments to carry on programs of soil erosion prevention, flood water control and prevention, methods of cultivation, cropping practices, land leveling,

Title to all property acquired, purchased, leased or received 24 by the SWCD shall be taken in the name of the Tohono O'odham 2526Nation. 27C. All SWCD funds shall be deposited in the general fund of the 28 Tohono O'odham Nation and shall be disbursed upon proper vochers 29submitted to the Treasurer of the Nation. 30 D. All participation in SWCD programs shall be voluntary. 31 SECTION 7 LIMITATION OF POWERS 32 A. Nothing in this ordinance shall affect existing water rights or
