Resolution No. <u>4-1-81-172</u>

WHEREAS, The Bad River Tribal Council desires an efficient structure for the Tribal Membership Committee;

NOW, THEREFORE, BE IT RESOLVED, that the following amendments be made to the Tribal Membership Ordinance and Membership Committee By-laws; Resolution No. 8-13-79-60:

1. <u>Article I, Section II of the Membership Ordinance is</u> <u>hereby amended to read:</u>

The Membership Committee shall be composed of nine (9) members of whom five (5) shall constitute a quorum.

2. <u>Article I, Section IV (intro) is hereby amended to</u> read:

The Membership Committee shall consist of a Chairman, a Vice-Chairman, a Secretary-Treasurer, and six (6) committee members. All members and officers shall also be Reserchers.

3. Article I, Section IV (b) is hereby amended to read:

The positions of Vice-Chairman and Secretary-Treasurer shall be selected from the tribal appointees by the Committee members themselves, by whatever method they chose.

4. Article I, Section IV (c) is hereby amended to read:

All members shall serve a two (2) year term beginning with their 1981 appointments.

5. <u>Article I, Section IV (d), (e) and (f) are deleted and</u> <u>subsection (g) is relettered (d) and is amended to read:</u>

Any Committee member who is absent from two (2) consecutive sessions without having notified the Chaiman or Acting Chairman of the Committee will be deemed derelict in duty and subject to removal. Written notices will not be required in the event of sudden illness or other unforeseeable and exigent cause. Removal of a challenged member shall be accomplished by an affirmative vote of five (5) members.

6. <u>Article I, Section III of the By-laws is amended to</u> delete the initial words " The Secretary " to commence with the words " The Secretary-Treasurer".

7: Article I, Section IV (title) is deleted, and the text

is amended to substitute for the initial words 'The Treasurer shall" the words "The Secretary-Treasurer" shall also.

8. <u>Article I, Section V is amended</u> by adding a terminal "s" to the word Resercher wherever it occurs.
