RESOLUTION NO. 6-3-87-66

WHEREAS, the Bad River Band of Lake Superior Tribe of Chippewa Indians is a federally recognized Tribe of which the Tribal Council is the governing body, and

- WHEREAS, the Bad River Band Fisheries Department has set up an Assessment for Perch and Walleye in Chequamegon Bay pursuant to the agreement signed by the Band and the State of Wisconsin in 1986, and
- WHEREAS, this assessment is to provide a foundation for determining how and when future fishing in that area can occur without depletion of the resource, and
- WHEREAS, in order for the assessment to provide the desired results other members who are not participating in the assessment need to be kept from gill netting in that area, and
- WHEREAS, the attached ordinance does prohibit such unauthorized gill netting in that area,
- NOW THEREFORE BE IT RESOLVED that the attached ordinance Chapter 316 is hereby approved and enacted this same day.
- AND BE IT FURTHER RESOLVED that any inconsistant ordinance or section previously enacted are hereby voided.

316. Prohibition Against Fishing in Assessment Area

- (a) No member shall fish with gill nets in the Bad River Assessment area in Chequamegon Bay during the assessment.
- (b) The assessment area shall be defined as a line from the westernmost boundary of the Bad River Reservation northeasterly to the western tip of Chequamegon Point in Chequamegon Bay.
- (c) The penalties for violations of this section shall not be less than \$25.00 and not to exceed \$1,000.00 or a loss of fishing or hunting privileges or both.
- (d) This ordinance shall only apply to the 1987 season and shall expire December 31, 1987.
