# Resolution Approving a Commercial Fishing Quota for Management Unit MI-2 of Western Michigan Waters of Lake Superior - 2013-2014 Fishing Season

WHEREAS, the Bad River Band of Lake Superior Tribe of Chippewa Indians is a federally recognized Indian tribe with a Constitution enacted pursuant to the Indian Reorganization Act of 1934, 25 U.S.C. Sec. 476: and

WHEREAS, the Bad River Band entered into an Agreement with the Red Cliff Band of Lake Superior Chippewa Indians and Keweenaw Bay Indian Community for the shared harvest of lake trout from the Western Michigan waters of Lake Superior: and

WHEREAS, the Tribal Council has reviewed the proposed fishing quota in MI-2 for the 2013-2014 fishing year and finds it necessary for the conservation of the Western Michigan waters of Lake Superior fishery resource.

NOW THEREFORE BE IT RESOLVED that the Bad River Band Tribal Council hereby adopts the following for western Michigan waters of Lake Superior:

The lean lake trout quota for Management Unit MI-2 is hereby set at 1.277. This quota shall remain in effect for the 2013-2014 fishing year. until November 28, 2014.

#### **REQUEST FOR AGENDA ITEM**

For the 2013-2014 fishing season, request to maintain the season for commercial fishing of lake trout and lake whitefish in Management Unit Michigan-2 waters of Lake Superior and to adopt a combined lean lake trout quota of 6.000 for all tribal and state users, with a breakdown as follows:

State	3,000
Red Cliff	1.277
Bad River	1,277
Keweenaw Bay	446

# SUMMARY

Managers of the tribal commercial fishery in Michigan waters of Lake Superior. comprising staff from the Red Cliff Band of Lake Superior Chippewa, Bad River Band. Keweenaw Indian Community, and the Great Lakes Indian Fish and Wildlife Commission (GLIFWC) have been monitoring the lake trout and lake whitefish fishery since the mid-1980's.

From 2001 to 2009, the relative abundance of lean lake trout present in the fishery independent spring lake trout index survey declined in the Michigan-2 management unit, while during the same period fishing effort increased.

The marked decline in the abundance of target fish species in the Michigan-2 management unit led to agreement by fisheries staff that emergency action was needed and the lean lake trout quota was reduced and the commercial fishing season was shortened.

The shortened fishing season and reduced quota in Michigan-2 management unit has allowed the spawning lake trout population to stabilize and the juvenile lake trout population to significantly increase. These positive population trends were reflected in the management unit's current lake trout population model.

Although the lake trout population in the Michigan-2 management unit is starting to recover, it has not fully recovered and the combined lean lake trout quota of 6,000 is still needed to protect the spawning lake trout population in the unit.

Maintain the commercial fishing season and approve the Tribe's annual quota of 1.277 lean lake trout in Michigan-2 management unit for the 2013-2014 fishing season.

RE:	Total Allowable Catches (TAC's) for Michigan Waters

On October 29, 2013 biologists met to discuss the current stock assessment models for the Michigan 1842 ceded territory management units as agreed to at our September 19, 2011 meeting. The models indicate that the stocks have remained stable therefore it is recommended that the current quotas be maintained at:

MI-2 TAC = 6,000
MI-3 TAC = 5,000
MI-4 TAC = 50,000
MI-5 TAC = 34,000

These TAC's reflect the number of lean lake trout harvestable by all user groups - tribal commercial and subsistence, state commercial, sport fishing, and assessment fishing within Michigan waters of Lake Superior in the 1842 treaty ceded area.

The 1842 Ad hoc modeling group agreed to meet annually for the purposes of updating and evaluating stock assessment models, and to recommend appropriate adjustments to the TAC.

As in past years, I plan to forward these recommended TAC's to the appropriate Michigan DNR personnel.
