RESOLUTION NO. 07-72

Court of Appeals, Court Code of 2004

WHEREAS, The Lac Courte Oreilles Band of Lake Superior Chippewa Indians ("Tribe") is a federally recognized American Indian Tribe, organized pursuant to the Indian Reorganization Act of 1934, 25 U.S.C. § 461 et seq; and

WHEREAS, The Lac Courte Oreilles Tribal Governing Board ("Tribal Governing Board") is the governing body of the Tribe, pursuant to the Lac Courte Oreilles Constitution, Article III; and

WHEREAS, The Tribal Governing Board pursuant to Article V (s) of the Lac Courte Oreilles Constitution has the authority to "promulgate and enforce ordinances governing the conduct of members" and provide "for the maintenance of law and order and the administration of justice by establishing a tribal court and defining its duties and powers; and

WHEREAS, The Tribal Governing Board adopted the Lac Courte Oreilles Tribal Court Code of 2004 by Resolution No. 04-26 which includes Chapter 175, Court of Appeals; and

WHEREAS, The Tribal Governing Board has decided to amend Chapter 175, Court of Appeals, of the Lac Courte Oreilles Tribal Court Code to require the inclusion of an Attorney Judge on the three-Judge Court of Appeals, a preliminary review to determine whether the appeal presents an error of law or fact, the parties to pay their costs of appeal, to allow the Court to require the payment of a cash deposit and to order a party to pay costs and attorney fees of the other party in the event of a frivolous appeal.

NOW THEREFORE BE IT RESOLVED, that the amended Chapter 175 of the Lac Courte Oreilles Tribal Court Code shall be, and hereby is, adopted pursuant to Article V (s) of the Lac Courte Oreilles Constitution.
