RESOLUTION NO. 2023-24

AMENDED REVISION OF THE LAC COURTE OREILLES BAND OF LAKE SUPERIOR CHIPPEWA INDIANS GAMING ENTERPRISES HOLIDAY PAY POLICY PAP.9.6.080

- WHEREAS, the Lac Courte Oreilles Band of Lake Superior Chippewa Indians is a federally recognized Indian tribe ("Tribe") organized pursuant to the provisions of the Indian Reorganization Act of 1934, 25 U.S.C. §5101, et seq.; and,
- WHEREAS, the Tribal Governing Board serves as the governing body of Lac Courte Oreilles Band of Lake Superior Chippewa Indians pursuant to Article III, § 1 of the Amended Constitution and Bylaws of the Lac Courte Oreilles Band of Lake Superior Chippewa Indians; and
- WHEREAS, the Tribal Governing Board pursuant to article V, § 1(n) of the Amended Constitution and Bylaws of the Lac Courte Oreilles Band of Lake Superior Chippewa Indians shall "regulate, by the enactment of ordinances, the conduct of business within the territory of the band" and Article V, § 1(h) "to engage in any business that will further the social or economic well-being of members of the Band; and
- **WHEREAS**, the Tribal Governing Board duly enacted PAP.9.6.080 and now wishes to amend such section.

NOW THEREFORE BE IT RESOLVED, that the Tribal Governing Board hereby expands the days included in the Gaming Enterprises Holiday Pay Policy to provide additional holiday leave days to Gaming Enterprises employees.

NOW THEREFORE BE IT FINALLY RESOLVED, as follows:

Section 1. Amend: Subsection PAP.9.6.080(b)(B) of the Lac Courte Oreilles Tribal Code of Law is amended as follows: The following days are considered observed holidays: New Year's Day, Martin Luther King Jr. Day, Treaty Day, President's Day, Easter Sunday, American Indian Day, Memorial Day, Juneteenth, We'enh Day, Independence Day, Honor the Earth Powwow

Saturday, Labor Day, Indigenous Peoples Day, Veteran's Day, Thanksgiving Day, Christmas Eve Day, Christmas Day, and New Year's Eve Day.
