RESOLUTION NUMBER TMBC0473-12-07 OF THE DULY ELECTED AND CERTIFIED GOVERNING BODY OF THE TURTLE MOUNTAIN BAND OF CHIPPEWA INDIANS

- WHEREAS, the Turtle Mountain Band of Chippewa Indians, hereinafter referred to as the Tribe, is an unincorporated Band acting under a revised Constitution and By-Laws approved by the Secretary of the Interior on June 16th, 1959 and amendments thereto approved; and
- WHEREAS, the Preamble to the Constitution and By-Laws approved by the Secretary of the Interior on June 16th, 1959 and amendments thereto provides that the Tribe formed its Constitution to develop and enjoy the advantages of democratic processes and opportunities to promote the general welfare, education and prosperity of all Tribal members, and
- WHEREAS, Article IX (a) Section 1 of the Turtle Mountain Constitution and By-Laws empowers the Tribal Council with the authority to represent the Band and to negotiate with Federal, State, and Local Governments and with private persons; and
- WHEREAS, Article IX (a) Section 5 of the Turtle Mountain Constitution and By-Laws empowers the Tribal Council with the authority To enact ordinances, subject to the review of the Secretary of the Interior, or his duly authorized representative, governing conduct of the members of the Band and Indians from other tribes on the reservation, and
- WHEREAS, the Tribe hereby publicly commends Mr. Willie Davis for his hard work and perseverance in bringing the issues related to Tribal members with disabilities before the Tribal Council and the Turtle Mountain Community; now
- THEREFORE BE IT RESOLVED that the attached revised version of the Americans with Disabilities Act is hereby enacted into Tribal law, with the appropriate numbering to allow it to be placed in its proper place within the Turtle Mountain Tribal Code.
