## RESOLUTION NUMBER TMBC1262-07-18 OF THE DULY ELECTED AND CERTIFIED GOVERNING BODY OF THE TURTLE MOUNTAIN BAND OF CHIPPEWA

- WHEREAS, the Turtle Mountain Band of Chippewa Indians, hereinafter referred to as the Tribe, is an unincorporated Band of Indians acting under a revised Constitution and bylaws approved by the Secretary of the Interior on June 16, 1959, and amendments thereto approved; and
- WHEREAS, Article IX (a) Section 1 of the Turtle Mountain Constitution and Bylaws empowers the Tribal Council with the authority to represent the Band and to negotiate with the Federal, State and local governments and with private persons; and
- WHEREAS, the Tribe, in accordance with Title 22 of TAPA empowers the Tribal Council with the authority to adopt a rule upon less notice than provided in this chapter and states in writing its reasons for that finding, and may proceed, without prior notice or hearing or upon any abbreviated notice and hearing it deems practicable, to adopt an emergency rule if the Tribal Council finds imminent peril to the Tribal health, safety, or welfare; and
- WHEREAS, Shauna Reed is an employee of Grand Treasure Casino and has a history of kicking a customer while at work, violence, threats with a stolen gun, etc., and most recently was reported for domestic violence and a protection order was issued; and
- WHEREAS, she has had no disciplinary action taken against her, thus creating a violent workplace and place of business; and
- WHEREAS, in order to protect our tribal members and the general public, and her allegedly threatening the life of a tribal member with a stolen gun, the Tribe is taking action to terminate her; now
- THEREFORE BE IT RESOLVED that the Tribe is terminating Shauna Reed from the Grand Treasure Casino immediately for emergency cause in order to protect our tribal members due to the aforementioned allegations.

## CERTIFICATION
